



**LETTER OF AGREEMENT

\_\_\_\_\_ (address), understand that the City of Ocoee will be replacing and relocating the water main along my rear property line. The relocated water main will require a new meter box/water service and plumbing from the new meter located in front of my home to the existing plumbing entering my home. I further understand that the City will conditionally offer to complete the work using City forces and/or a City selected contractor/plumber at the City's expense.

The conditional offer is based upon:

1. Offer shall be accepted by property owner no later than April 2, 2010.
2. Existing plumbing can be reasonably accommodated, as determined by the City.
3. Restoration shall be limited to grading and/or grassing/solid sod which matches existing conditions.
4. Resident shall remove any obstructions, improvements, plantings, materials, appurtenances, and vehicles that would be in conflict with the work and insure access to the work area.
5. City shall warrant relocated service until the completion of the project's construction.
6. City's warranty shall not extend to the internal plumbing within the home, including but not limited to: piping, valves, strainers, filters, water softeners, hot-water heaters and/or appliances.
7. Property owner has the option of reviewing the plumbing route on-site with a City representative before the plumbing is initiated; and at his/her/their sole discretion, has/have the right to suspend plumbing work. If the property owner elects not to authorize the work or chooses to suspend the work, the owner will be responsible for any or all of the remaining plumbing work and associated restoration.

Therefore, with my understanding and concurrence of the outlined conditions, I have executed this "Letter of Agreement" which authorizes the City to undertake and complete the needed external plumbing on my property, at the City's expense. In consideration of the City's efforts, I agree and grant permission to the City and its representatives the right to enter my property to perform any and all necessary plumbing and shall accept the conditions of this offer with said right expiring upon completion of the work. Furthermore, I agree to hold the City and its employees and City selected contractor/plumber harmless from any loss to my property or personal items as a result of the City's work and I shall not be entitled to obtain any restitution and/or compensation for any losses or damages as a result of the City's work and/or material.
