#### **The following is updated and corrected information:**

After the robbery of McCoy Federal Credit Union, **the five** suspects drove away in the stolen Dodge Stratus and switched vehicles. Two vehicles, a black Pontiac GTO and a purple Pontiac Grand Am were observed by witnesses after suspects left the stolen vehicle. As a result of the BOLO, an OCSO Deputy on patrol observed a 2005 Pontiac GTO driving east away from the area. The vehicle drove away in an evasive manner. The OCSO Deputy continued searching the area and discovered the vehicle parked in an apartment complex on Dorsher Road. He observed two black males and a white male standing near the vehicle that began walking away quickly as he approached. The males then fled on foot, jumped over a fence but were discovered and later detained by units in the area. Evidence inside the vehicle linked the males to the McCoy Federal Credit Union Robbery.

The following males were charged with Armed Robbery with Firearm/Mask, Aggravated Battery with Firearm, and Armed Kidnapping:

1. Marcell A. Stalling, B/M, 6/15/1990
2. Kyle Sawyer, W/M, 7/16/1989
3. Michael Holliday, B/M, 8/1/1990

The Ocoee Police Department is asking for assistance in locating the purple Grand AM and the identity of the other two males observed in the bank.
