I THE UNDERSIGNED, UNDERSTAND AND AGREE THAT I AM RESPONSIBLE FOR ALL CHARGES FOR ABOVE SERVICES REQUESTED AND WILL CONTINUE TO BE RESPONSIBLE FOR SAME UNTIL SUCH TIME AS I REQUEST TERMINATION OF SERVICE.

THE DEPOSIT WILL BE APPLIED AS A CREDIT TO THIS ACCOUNT AFTER TWENTY FOUR (24) CONSECUTIVE MONTHS OF SERVICE WITHOUT WATER SERVICE BEING SHUT OFF OR A NOTICE OF LIEN BEING FILED FOR NON-PAYMENT. EFFECTIVE OCTOBER 1, 1994 INTEREST WILL ACCRUE MONTHLY ON DEPOSITS. ACCOUNTS CLOSED PRIOR TO TWELVE (12) CONSECUTIVE MONTHS OF SERVICE WITHOUT WATER SERVICE BEING SHUT OFF OR A NOTICE OF LIEN BEING FILED FOR NON-PAYMENT, FORFEIT ANY ACCRUED INTEREST. IN THE EVENT OF ANY UNPAID AMOUNT TO THE CITY OF OCOEE, THIS DEPOSIT AND ACCRUED INTEREST WILL BE APPLIED TO THE SATISFACTION OF SUCH AMOUNT, AND THE BALANCE, IF ANY, WILL BE REFUNDED.

IN THE EVENT THAT WATER SERVICE IS SHUT OFF OR A NOTICE OF LIEN IS FILED FOR NON-PAYMENT:

1. IF DEPOSIT HAS BEEN REFUNDED, A NEW DEPOSIT WILL BE REQUIRED.
2. IF DEPOSIT HAS NOT BEEN REFUNDED, ALL INTEREST WILL BE FORFEITED AS A PENALTY. AFTER SERVICE IS RECONNECTED OR LIEN RELEASED, THE DEPOSIT WILL ONCE AGAIN BEGIN TO ACCRUE INTEREST AND BE REFUNDABLE AFTER TWENTY FOUR (24) CONSECUTIVE MONTHS OF SERVICE WITHOUT WATER SERVICE BEING SHUT OFF OR A NOTICE OF LIEN BEING FILED FOR NON-PAYMENT.

ALL PAST DUE ACCOUNTS WILL BE CHARGED A \$10.00 LATE FEE EACH MONTH IF THERE IS ANY OUTSTANDING BALANCE DUE ON THE ACCOUNT FIVE (5) CALENDAR DAYS AFTER THE DUE DATE PRINTED ON THE BILL. NO EXCEPTIONS.
